1. The subject matter of the maintenance contract is the maintenance of a RADAR*pilot720*° system with the

This agreement may only be concluded for version 4 RADAR*pilot720*° systems.

The contract offers two performance levels. The basic level includes the maintenance of the software, and the maps provided by Argonav GmbH. As a supplement to this, an extension of the hardware warranty can be completed as a second performance level.

- 2. The **basic level** includes the following services: free delivery of software and map updates for the RADAR*pilot720*° on CD.
 - Granting of a preferential price for the purchase of fee-based software options: 20% discount on the list price (this excludes electronic maps from other providers)
 - Free-of-charge deliveries of updates for maps which were included the RADAR*pilot720*° scope of delivery. These are the publicly available maps of Central European waterways, especially the official maps of the German Water and Shipping Administration (WSV).
 - A bi-annual cycle is planned for the delivery of updates.
 - Online maintenance of the RADAR*pilot720°.*
 - For this purpose, the RADAR*pilot720*° System on board has to be operated within a network, where a router provides a connection to the Internet. A VPN tunnel is used for the RADAR*pilot720*° on board dial-up connection. Establishing the VPN tunnel has to be initiated on board. Also the charts, provided by Argonav GmbH, will be updated using the internet connection.
 - Phone support for all questions regarding the RADAR*pilot720*° (during normal office hours)

The remuneration is specified at EUR 350 per year (for individual systems), which is due for payment 2 weeks after the contract start date or receipt of follow-up invoices. The total amount of the remuneration is the initial amount plus the applicable statutory VAT (currently at 19% for German customers).

If two or more RADAR*pilot720* ° systems are used on a ship (e.g. one with radar overlay and one as a map and AIS display), the maintenance fee of the basic level for this ship is only billed once.

3. Optional extension of the maintenance agreement: Extended hardware warranty

Expansion of the hardware warranty to the RADARinterface card and all the hardware of the navigation computer. The extended hardware warranty is not limited timewise, as long as a maintenance contract is established. If parts of the computer are discontinued, Argonav GmbH shall be obliged to provide a new computer free of charge should this become necessary.

The hardware warranty does not cover travel and labour costs for the replacement of the affected components.

The extended hardware warranty will become relevant after a lapse of the statutory warranty period (1 year for commercial customers). If this option is ordered for a new RADAR*pilot720*°, a billing will not be carried out during the warranty period. It can also be ordered subsequently, but only up to the end of the warranty period.

The remuneration is specified at EUR 350 per year, which is due for payment 2 weeks after the contract start date or receipt of follow-up invoices. The total amount of the remuneration is the initial amount plus the applicable statutory VAT (currently at 19% for German customers). It must be paid in addition to the fees for the basic level. Thus, the total price for the maintenance contract is EUR 700 per year (net).

4. Optional extension of the maintenance agreement: Mobile radio option

A dedicated SIM card can be provided for the mobile internet connection which is required for the data transfer between the RADAR*pilot720*° System on Board and Argonav GmbH. This card is installed into a mobile wireless router that is connected to RADAR*pilot720*° system through a network cable. In addition to the remote maintenance functions, the connection can also be used to access key services during the operation of the RADAR*pilot720*° (e.g. water level download). A utilization of the mobile radio card for other purposes is not permitted. If necessary, a mobile wireless router and the appropriate outdoor antennas can be ordered - model and price upon request.

The price for the mobile radio option is Euro 70 per year. This includes all fees and connection charges.

- 5. The contract period is 1 year. If the agreement is not terminated accordingly (see 6), it will automatically be extended for another year.
- 6. The maintenance contract can be terminated in writing up to 1 month prior to the expiration without stating any reasons.
- 7. If the computer or hard drive is replaced by a sales partner in case of a necessary repair, then the serial number, hardware ID and host ID number must be notified to Argonav GmbH immediately.

The customer assures that he is fully aware of the preceding contractual text.

The maintenance contract is concluded with the following scope:

- Software maintenance (basic level)
- Extended hardware warranty
- Mobile radio option: SIM card for remote maintenance
